Objective: This Pequannock Valley Rotary (PVR) fundraiser will provide the community the opportunity to exhibit photography. Ticket sales and a 25% commission on all sales will go to the Pequannock Valley Rotary club's Save a Life fund to help support police, first aid squads and fire depts. in Lincoln Park, Riverdale, Pequannock Township & also support The Riverdale Art Center.

Entry requirements – please read carefully:

Eligibility: Open to all adults 18 years and older residing in New Jersey. All work must be original.

Categories: Photos can be submitted in four categories: landscape/nature, animals, portraits, abstract. A panel of three judges will select winners of 1st and 2nd place, and honorable mention, in each category. **Prizes will be awarded to the winners.**

Specifications: All work must be completely prepared for exhibition. Works must be framed or have finished edges and be prepared with screw eyes and wire attached ready for hanging. Photos may be up to 16 x 20 (not including size of frame). The RAC/PVR reserves the right to reject work considered unsuitable, misrepresented, or not adhering to the above conditions. *Withdrawal of work nullifies your participation.*

Entry Fees: The non-refundable entry fee is \$35 for up to 3 photos, \$5 for each additional photo, no more than 5 photos total (\$45). Each entry fee entitles artist to one free admission ticket to Opening Reception with wine and hors d'oeuvres. Additional tickets are \$10 each.

Entry Instructions: Jurying is by photos. All photos must be clearly labeled on the back with the Artist's name, Title of Work, Dimensions and Artist's Price.

Delivery: Please deliver all photos on Saturday, Feb. 25 or Sunday Feb. 26 from 12 to 4 pm to:

The Riverdale Art Center, Salon No. 5, at 5 Mathews Ave., Riverdale, NJ 07457 (just off Exit 53 from 287, left on Hamburg Turnpike about a mile to Mathews Ave., go left, and enter 5 Mathews Ave. complex just past RR tracks.)

Liability: Works will be handled with the utmost care by The Riverdale Art Center. The RAC will make every reasonable effort to safeguard the artwork you are providing us to be displayed at the RAC's Salon No. 5 Gallery, 5 Mathews Ave., Riverdale, NJ 07457. However, we regret that neither the Riverdale Art Center (the RAC) nor Pequannock Valley Rotary Club can be responsible for any damage to your work while it is on our property. Signing this "Hold Harmless" agreement upon submission of your work indicates your agreement to this disclaimer. Artists are encouraged to have their own insurance.

Agreement: Submitting an entry to this Show constitutes an Agreement with all conditions of this Exhibition and Prospectus. PVR and The RAC reserve the right to use accepted work for documentation, education, and publicity purposes and reserve the right to reject any work not conforming to this agreement.

Sales: A 25% commission will be retained by PVR for each work sold. The artist will retain 75% of the sale price. All works will be sold at the price indicated on the entry form only. If you choose to donate your work, simply put "Donation" on the entry form below.
